GAMA Healthcare Ltd is committed to achieving Net Zero emissions by 2045.

Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

Baseline Year: Jan-Dec 2021 (note: this is the baseline year for Scope 1 and 2 emissions)

Additional Details relating to the Baseline Emissions calculations.

GAMA Healthcare Ltd started measuring its carbon footprint in 2021. In 2021 Scope 1 and Scope 2 emissions measurements were collated. Scope 3 emissions were not measured for 2021 due to data unavailability. Scope 3 emissions measurement started in 2022. Hence Jan-Dec 2021 is the baseline year for Scope 1 and 2 emissions and Jan-Dec 2022 is the baseline year for Scope 3 emissions.


Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 2,8000 tCO₂e by 2027. This is a reduction of 2.26%.

Planned 5-year progress against these targets can be seen in the graph below:

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline for Scope 1 and 2. The carbon emission reduction achieved by these schemes equate to **28.8 tCO₂e**, **a 23.2%** reduction against the 2021. baseline and the measures will be in effect when performing the contract

- ISO 14001 Environmental Management System
- Laptop battery saving mode set up as default in all devices.
- Switched to a green electricity tariff for 1 out of 2 UK GAMA facilities

In the future we plan to implement further measures such as:

- Installation of solar panels at a facility owned by GAMA
- Voltage optimisation across 2 UK GAMA facilities
- Phase down business flights
- Employee EV Salary sacrifice scheme

In the future, we will also be looking to address the largest source of our emissions – our upstream and downstream transportation and distribution of products. However, with this source of emissions being outside of our direct control (as it is all provided by Third Party Logistics suppliers), at this initial stage of carbon reductions, GAMA is focusing on emissions which are directly in our control.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard¹ and uses the appropriate Government emission conversion factors for greenhouse gas company reporting².

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard³.

This Carbon Reduction Plan has been reviewed and signed off by the Executive Committee in a meeting held on the 22nd of May 2023.
